### PRINT AND REVIEW | Streamline Health Training Forms

Bring a printed copy of the Lifeguard Instructor training forms to class.

### COMPLETE RED CROSS ONLINE COURSE | Complete Online Course Before First Class Date

Red Cross requires participants to complete the 2-hour lifeguard instructor online course, prior to the first-class date. You will receive an email from Red Cross, with a course link and directions on how to complete the online course. If you cannot find the Red Cross email, search the following address, and check your junk folder (rclcsfdevteam@redcross.org). If the Red Cross online course is not in constant use, the program may time out and course work lost. Be sure to log out when taking breaks and screen shot each section you complete.

#### PREREQUISITES

American Red Cross requires participants to successfully complete the following prerequisites, to receive certification. Refunds will not be issued to participants who do not successfully complete all course prerequisites and course completion requirements, according to the American Red Cross standards. Please make sure you can complete the following course prerequisites and course completion requirements before you attend class. Thank You!

Red Cross requires the following for successful course completion: participants must attend all scheduled dates and times, demonstrate proficient skills, and pass a written exam with a score of at least 80 percent.

- 1. Participants must be at least 17 years old on the last class date
- 2. Participants must have current Red Cross deep water Lifeguard, First Aid, CPR/AED Professional Rescuer certifications (2017 LGI certification accepted)
- 3. Participants must complete the American Red Cross 2 Hour Online Course prior to the first-class date
- 4. Successfully complete one prerequisite skill assessment scenario. The prerequisite skill assessment scenario evaluates the following:
  - Swimming approach
  - Surface dive in deep water | 7 10 feet
  - Passive submerged rescue
  - Rapid extrication, with an assisting rescuer
  - Rapid assessment
  - Single-rescuer CPR | 3 minutes
